Community Park

The Community Park is located at 4350 Shoreview Lane and is a central amenity for our community.

Keys

A key to the Community Park entrance gate can be obtained from Northwest Communities. Keys are the responsibility of each property owner and should not be distributed.

Bathrooms

There are 2 bathrooms located within the Community Park. The entrance code to the bathrooms is 0413#.

Access

Access to the Community Park is solely for association members. Holding open or propping open the gate for non-members is not allowed.

Vandalism

There have been multiple instances this year in which the bathrooms have been vandalized. It is unclear if the vandals live in the Community, or not. Please keep an eye out for vandals and report suspicious activity to the Coeur d'Alene Police Department; as well notifying our management company.

Reservations

The Community Park may be reserved by posting notice at the park 48 hours prior to use on the gate with your name and contact phone number. The host must be present at the gathering.

Park Rules

The Park Rules are posted in numerous locations around the Park and all owners and their guests should abide by them at all times.
